  - a) Subscription to the 93<sup>rd</sup> season purchase at the CZECH RADIO shop
    - The pro rata amount for the cancelled concerts will be deducted from the price of the new season ticket at the Czech Radio ship.
      Advance sales for the new concert season will take place at the shop from 8 June 2020 to 19 June 2020.
  - b) Subscription to the 93<sup>rd</sup> season purchased ON-LINE
    - The pro rata amount for the cancelled concerts will be refunded to your account after filling in the admission fee refund form found on <a href="https://www.colosseumticket.cz">www.colosseumticket.cz</a>.

- 3. If you are not interested in a subscription to the 94<sup>th</sup> concert season or utilising the compensatory ticket offer
  - a) the admission fee will be refunded at the Czech Radio shop upon presenting your original season ticket from 8 June to 30 June 2020
  - b) the admission fee will be refunded to your account based on an email sent to <a href="mailto:socr@rozhlas.cz">socr@rozhlas.cz</a> by 30 June 2020, where you will state that you wish to have the admission fee for the cancelled concerts refunded and indicate your bank account number.
